MATTERS FROM THE PUBLIC

Mr. Nauman Azeemi came before the board to discuss the potential of the Park District welcoming the Cricket World Cup in 2024. He stated that the local Adult Cricket League had approached several venues that unfortunately had not been able to accommodate the request. He stated his intentions to have the representatives of the League petition the board in person at some future date. He then proceeded to discuss his desire to run a cricket league using the Park District's fields for the league in general if the Park District were to "run out" the two Cricket groups that have regularly rented the fields. He stated that he has been coming to the board for 4 years to petition that his league be brought into the discussion of Rentals. President Fuentez required an answer to be given to Mr. Azeemi in writing as to how the Park District's rental process works.

Commissioner Mustafa complains that Superintendent Cox serves the old customers that Shawqi claims that he brought.

Belinda Mustafa reminds that tomorrow is Giving Tuesday, so any donation to help the foundation woulkd be appreciated. She states that the Craft show is going well, and everyone should be ready come Sunday, she is looking forward to it.

QUESTIONS AND ANSWERS FROM COMMISSIONERS

Commissioner Mustafa stated directly that he wanted to speak and not be interrupted as he would tell whomever was interjecting in his statement to shut up and he "wouldn't care"/ wants to talk and not be interrupted, because he will tell them to shut up and not care. The Monday preceding the meeting, there was an incident, that the Commissioner stated got out of control and "broke up everything". He stated that there was no leadership within the Park District. He recounted again his issue with a CCAC Employee, stating that because he was a Foreigner, the matter was swept under the rug, and the employee in question was promoted, for which he blames Secretary O'Brien, stating that the decision was not right and the matter wasn't handled to his satisfaction. He went on to allege that Front Desk Coordinator Dzik has been racist towards him, stating that she told him to "take his religion elsewhere", but promptly corrected himself to state she said he "should take his business elsewhere". He went on to state that Secretary O'Brien had discussed the incident with Superintendent Cox and that the matter was closed, and expressed his personal displeasure that he was not informed of what was done to the employee in question, and that it was not right that he was not informed of any punitive measures against her. He alleged that he was the only person bringing business to the Park District, stating that Superintendent Cox and her employees couldn't do it. He alleged that Superintendent Cox requiring that Cricket Groups looking to rent our facilities needed to have insurance coverage was a ploy for money. He claimed that his group stayed in the lobby until 8 pm after their recent Women's Worship event, and that Superintendent Cox did nothing to stop her employees from talking to his wife about the rental, while demanding to know why the Park District was not covering an injury she had sustained while

running up the stairs. He stated that he was going to bring a lawsuit against the Park District to "shake things up in the building".
