MATTERS FROM THE PUBLIC

Commissioner Mustafa brought forth a rebuttal to the allegations from a staff member as heard by the Board on the July 7, 2022, Workshop Meeting. He offered complaint over the length of time she was given to talk versus what is considered to be his norm. He brought up that Supt of Parks Bessette, Executive Director O'Brien and CCAC Manager Kress saw the camera footage and that there were inconsistencies with her allegation. Commissioner Mustafa had asked Executive Director O'Brien to have the employee come and offer a public apology to him, but this was unable to occur. Executive Director O'Brien informed Commissioner Mustafa that the Park District cannot force an employee to make an apology as a matter of the First Amendment. Commissioner Mustafa then offered complaint about the manner of dress at the park district. Commissioner Mustafa also wants people to see the camera, talking about behavior of employees, and see people texting while on the clock. Belinda Mustafa suggested all employees be made to wear a uniform. Commissioner Mustafa also offered complaint about the Police being so far away from him that they did not help in the alleged dispute. He then offered complaint about things being done to shorten meetings, about people not backing him up, and how disgusted he is to be a commissioner here. Commissioner Mustafa also made guarantees of high attendance number events, but states that no one wants it to be picked up. He demanded that the employee be dragged before the Board and be forced to give a public apology. Commissioner Vences ended the conversation with a suggestion that the discussion was going nowhere. and we should move back to the regularly scheduled meeting.
