START OF PLAY: Match play for Open and Letter Divisions may start as early as 9AM, Friday, October 11th.

CHECK-IN: Open players must check-in in person at Centre Court, or by phone with the Referee by 5PM, Thursday, October 10th.

MEALS: 2 dinners and 3 lunches (if play begins before noon on Friday) will be provided at the courts.
