## MATTERS FROM THE PUBLIC

Commissioner Mustafa stated that he had a good conversation with Secretary O'Brien, discussing all sorts of ideas of places to go from here. Executive Director O'Brien agreed that the conversation was a good one. Commissioner Mustafa demanded that Secretary O'Brien take immediate action against "those people" provided they were on the clock when the police report was filed. He also requested that the investigation be reopened as well, and wanted to place a motion to bring up the names of those who filed the police report against him. Secretary O'Brien disagreed that any names were given let alone confirmed when Commissioner Mustafa began guessing them.
