NOTICE IS HEREBY GIVEN pursuant to new Section 7(e) of the Open Meetings Act that the regular meeting of the Board of Park Commissioners of the Hanover Park Park District (the "Park Board") scheduled to be held on August 23, 2021 at 7:00 p.m. in the Board Room of the Community Center, 1919 Walnut Avenue, Hanover Park, Illinois, 60133, may be conducted by audio or video conference without a physical quorum of the members of the Park Board present because an in-person meeting is not practical or prudent due to a disaster, that being the COVID-19 pandemic and the applicable restrictions imposed under various laws, rules, restrictions, Executive Orders and/or announcements issued by Illinois Governor J.B. Pritzker and/or Ngozi O. Ezike MD, Director of the Illinois Department of Public Health, including without limitation "Restore Illinois: A Public Health Approach to Safely Reopen Our State", which currently allows for full capacity limits to the extent that the indoor space will still accommodate unvaccinated individuals who must still wear a mask and social distance. The President of the Park Board has determined that an in-person meeting of all members of the Park Board, Park District staff and all members of the public and the press is not practical or prudent because of the disaster. As a result, some of the members of the Park Board may participate in the Park Board meeting via electronic means.

The members of the Park Board, the press, and the public may attend said meeting in person; however, due to social distancing restrictions, the Park Board may have to limit the number of Staff and members of the press and the public allowed in the meeting room at any one time.
